PELLA CONGREGATIONAL COUNCIL MEETING MINUTES NOVEMBER 7, 2023, 7:00 P.M.

Council members present were: Tim Averett, President, Kaci Dean, David Christensen, Linda Wick, and Bec Kallevig. Also in attendance were Lance Averett, Treasurer and Pastor Barb Haugerud. Visitors in attendance were confirmation students Dallas Brown, Year 2, and Cooper Brown, Year 3.

AGENDA/REPORTS

Meeting called to order by President Tim Averett at 7:04 pm. Pastor Barb led an opening prayer.

Minutes from October 10, 2023 meeting were read and approved as reported.

Lance Averett gave the financial report which was also handed out in written form including the dedicated funds report and balance sheet. The General Fund income from offerings for October was \$35,031.22 compared to \$29,648.97 last month. General Fund expenses were \$30,843.60 compared to \$29,828.81 last month. The year to date change in the General Fund is -\$15,261.14 which matches the current year changes on page two of the Balance Sheet and compares to -\$19,457.76 last month. This is an improvement of \$4,196.62 compared to last month.

The Balance Sheet shows our Yellowstone Bank checking account with a balance of \$78,676.31, compared to \$74,869.67 last month. The Money Market account is \$169,743.90 compared to \$169,420.14 last month. Interest earned was \$323.76.

The Set Free/Future Repairs report shows a Stockman Bank checking balance of \$6,302.01 compared to \$5,802.01 last month. An increase of \$500 this month. The "Stockman Bank CD" value remains at \$90,000.00. Minutes approved as reported.

Pastor Barb went through her written report noting she served at 1 memorial, and 1 baptism.

Christian Education Committee—No meeting.

Property & Grounds—The Boy scouts finished placing the mulch last night. The bill has been submitted to the office. The leak in the roof is fixed. Theil Brother's patched the roof. The drain in the pastor's house was plugged and that is now fixed. No major repairs were needed for that. Mark will look into the plug for the kitchen. The sprinklers did get blown out before the snowfall. The curb painting will be done next spring. Written report submitted for review.
